Combining quantitative research based on questionnaire, case studies, and an annotated bibliography/literature review, this study described funding sources and current uses of video surveillance technology by passenger rail agencies, primarily in the United

States but also in Canada and worldwide. The final report has been approved by the oversight panel; publication is anticipated in June 2011.
