From Punishment to Public Health (P2PH) Receives \$3.9M to Interrupt Violence

John Jay's **From Punishment to Public Health (P2PH)** initiative recently received a \$3.9M award from the Bureau of Justice Assistance to launch the **Central Brooklyn Violence Interruption Collaborative**. This project builds on P2PH's partnership with the [Brownsville Safety Alliance](#) and Situation Tables, which aim to stabilize families in crisis and reduce the burden of violence in Brownsville, Brooklyn.

Course Modalities: An Open Conversation

John Jay is not an online college. But we look very much like a hybrid college if you look at spring 24 – spring 25 course scheduling.

I have been talking with the Council of Chairs about whether we ought to limit the percentage of hybrid and online course offerings in order to ensure more students receive the education they enrolled in. I will be talking with Faculty Senate today. I believe that a portion of our offerings should remain fully online, and perhaps some hybrid, but I think we should be offering a higher percentage of fully in person sections. Such sections bring students to campus to interact with one another, their professors and co-curricular programming that helps in their holistic growth.

I look forward to hearing your thoughts on this.
