

Discussion: Carol Kashow, Director of Athletics, presented the budget. The pool will undergo renovation starting in January 2018, which will result in the loss of facilities for the swim team and a debit for the department in loss of rental revenue and costs of renting outside facilities for the swim team. There are no plans to repair the saunas in the locker rooms, as it would be costly to repair and maintain. The spaces are currently used for storage.

New Business: Mark Flower, AVP of Finance and Administration, noted that the CUNY guidelines for procurement require SAA purchasing to follow the same process as purchases made through tax levy funds. SAA purchasing does not currently have to follow the Sunshine Act, though tax levy does.

New Business: The Student Council passed a resolution on Wednesday, October 18 in support of requiring equal representation across constituent groups on the task force.

Discussion: There is approximately \$150,000 available in surplus funds. All entities that receive SAA funds are eligible to submit a proposal for surplus funds. There are some concerns about what projects should be funded through the surplus. In the past, student clubs and organizations that missed the deadlines to submit club budgets through the Student Council have requested surplus funds for their club budgets. The concern is that these clubs are going outside of Student Council's procedure for approving club budgets, which means these budgets are not subject to the same criteria

and vetting as the club budgets that were submitted on time. There are also concerns that not allowing clubs to request surplus funds for their budgets is punitive and overly bureaucratic, which will discourage student engagement.

The motion is rescinded and will be on the agenda for the November 29, 2017 meeting.
