Dear Academic Affairs Colleagues,

We are in for some challenging times ahead. The federal government declared an end to opportunity funding for minority and Hispanic serving institutions, which has fueled some of our student success work for the last twenty years. The federal legislation known as the One Big Beautiful Bill will reduce Medicaid payments to New York State by almost one billion dollars next year and three billion the year after. This will directly affect New York's capacity to fund SUNY and CUNY colleges; we should realistically expect reductions.

The list of challenges keeps going, but I trust you are familiar with them at this point. I also trust you know this: we are a resilient and resourceful college committed to finding ways to manifest big outcomes from small investments and we will continue to do so. In times of turbulence, we hold fast to our mission, our community, and our willingness to work with each other and with our external stakeholders to find the ways forward.

Call for Bold Action from our AI Team

In the <u>Sept 23 update</u> I shared that a team of faculty and staff are participating in a year-long AAC&U Institute on AI, Pedagogy and the Curriculum. As part of that effort they have created a bold action plan that calls for change from all of us. As the Summary at the end of their plan (attached to this email) says:

Our overall goal is to partner with our college in creating a framework to support effective, ethical, and innovative pedagogical and curricular engagement with emerging technologies over the next three years. Our specific goals address the development of our students' learning agency with AI, with increasing faculty and staff resources and

training that includes AI with student-centered, inclusive, social justice pedagogies, and with improving and expanding communications and advocacy related to AI ethics and curriculum policies. By June 30, 2026, we aim to have engaged at least 10% of our students and faculty in AI literacy activities, to have revised our AI responsible use guidelines for review and adoption, to have designed a pedagogical and curricular framework for review, revision, and adoption, and to have a core emerging technologies community of at least 60 faculty, staff, and students involved in discussing and working with effective, ethical, and innovative college emerging technologies activities.

Strengthening Coordinated Care for Students

This fall, <u>Navigate360</u> continues to expand as a hub for coordinated student support: our shared effort to connect students with the right help at the right time.

Early Check-In requests should have landed in your mailboxes and Submissions are open until October 8th. Your participation helps us connect students with resources before they fall too far behind.

We've also streamlined the process for ongoing Alerts, which are faculty-submitted notices such as "missing assignments" or "attendance concerns" that trigger follow-up from advising or support staff. For example, an alert you raise for repeated absences may prompt an advisor to reach out and help the student get back on track.

Students can now also submit their own "Hand Raises" in Navigate to request help directly. Coming in spring 2026, new financial aid indicators will make it easier to identify and assist students who might be at risk of losing financial aid.


Student Emergency Fund – We Can Help
